8. TEACHING

(8a) Areas of special interest and accomplishments

(8ai) Highlights of teaching contributions

Summary Statement: Teaching leadership roles in my faculty have spanned across undergraduate (Entry-to-Practice [E2P] PharmD, BPSc) and graduate programs. Current teaching leadership in our undergraduate programs include core courses in the E2P PharmD (e.g., Patient, Pharmacist, and Health Care Systems Module in PHRM 100) and BPSc (PHAR 205 Clinical Epidemiology & Pharmaceutical Outcomes I) programs. In the graduate program, I co-lead PHAR 561 Pharmacoepidemiology which is cross-listed with the School of Population and Public Health (SPPH 551).

Highlight 1

Module Co-lead and Instructor (ongoing, E2P PharmD)

Course: Foundations of Pharmacy (<u>PHRM 100</u>) Pharmacist, Patient and Health Care System (<u>PPHC</u>) Module (3-credit module of mandatory 18-credit course in the first year of the E2P PharmD program)

Description: This course introduces foundational concepts to first year pharmacy students in my faculty's E2P PharmD program including the organization health care systems, economic evaluation and health technology assessment, contemporary issues in health care, and evidence evaluation.

Role(s): I designed this module along with Dr. Larry Lynd prior to the launch of the E2P PharmD program in 2015 then subsequently went on maternal and (unplanned) medical leave. Upon returning from leave in 2017, I have since assumed the role of module co-lead with Dr. Mark Harrison in the past two (2017, 2018) and current (2019) academic year where I am responsible for the overall organization of the module and administration of assessment activities in addition to delivering lectures on health and health care systems, contemporary issues in medication use including medication adherence and medication safety, and introduction to epidemiology.

2023/2024: During this period, I was sole lead for this module while my co-lead was on sabbatical.

Highlight 2

Module Co-lead and Instructor (ongoing, BPSc)

Course: PHAR 205 Clinical Epidemiology & Pharmaceutical Outcomes I (3-credit core course in the BPSc program)

Description: This course introduces second year BPSc students to clinical epidemiology and pharmaceutical outcomes including study designs, evidence evaluation, research synthesis, and health economics.

Role(s): I designed this course along with Dr. Mark Harrison. Since the initial offering in 2021/2022, I have been responsible for the overall organization of the module and administration of assessment activities.

(8aii) Scholarship of Teaching and Learning: Towards improving adherence teaching to healthcare professionals

Summary Statement: With my recruitment to my faculty as holder of the Professorship in Medication Adherence, one of my early teaching goals was to enhance the teaching of medication adherence to our students by introducing them to theoretical and practical aspects of the issue as well as highlight the important roles that pharmacists play. Colleagues in my faculty facilitated this goal by providing various adherence teaching opportunities. I provided guest lectures on medication adherence (4.5 hours total) in Patient, Pharmacist and Society (PHAR 201) a second year mandatory course in our previous BSc Pharmacy program during the 2013 and 2014 academic years. During the 2013 academic year, I was also invited by my colleague Tony Seet to collaborate on an adherence simulation activity that he delivers as part of Pharmacy Skills I (PHAR 202). In brief, this activity has historically involved giving students a vial filled with 28 lactose-filled gelatin capsules with a prescription label bearing directions to "take 1 capsule twice daily for the rest of your life" and asked to provide written reflections on their experiences at the end of the activity. I proposed the following additions to the activity: 1) ask students to report the number of pills remaining at the end of the activity - so that I may use this information to calculate students' adherence; 2) provide students with the Beliefs about Medications Questionnaire (BMQ) before and after the activity – so that I may assess whether the activity had any impacts on students' beliefs; and 3) gather a convenience sample of students' reflections – so that I may apply qualitative analyses to obtain students' perspectives about the teaching activity and their adherence understanding after participating in it. With mentorship from Dr. Simon Albon another colleague in my faculty, this collaboration resulted in the co-authorship of a published manuscript to describe this adherence simulation activity and novel multi-method research approach of evaluating its impact (Seet T, De Vera MA, Howren A, Chan D, Albon S. Medication Adherence Teaching Activity for First Year Pharmacy Students: A Description and Multi-Method Evaluation. Accepted Currents in Pharmacy Teaching and Learning. 2019 Aug 26:12(1):56-73).

This collaboration also introduced me to Scholarship of Teaching and Learning (SOTL) where I could apply my research expertise to the systematic inquiry of student learning and teaching practice. With literature reviews to support our manuscript noting a gap in the teaching of medication adherence in pharmacy schools in both the US and UK as well as very limited work done in Canada, an area of investigation has opened to me. Therefore, I am continuing in this SOTL with planned work including: 1) an environmental scan and scoping review of adherence teaching in pharmacy schools across Canada; and 2) qualitative interviews with individuals who teach medication adherence in health professional schools to gather perspectives on challenges, facilitators, and approaches to improving the teaching of medication adherence.

9. SCHOLARLY AND PROFESSIONAL ACTIVITIES

(9a) Areas of special interest and accomplishments

(9ai) Research Program

As an **epidemiologist** and **health services researcher**, my research program is informed by the overarching objective of supporting and informing patient journeys in living with, and managing chronic disease. I have expertise in conducting **population-based studies**, honed by analyzing **administrative databases** in BC (PhD in epidemiology, UBC) and Quebec (postdoctoral fellowship in perinatal pharmacoepidemiology, University of Montreal). I have also developed expertise in conducting **prospective studies** using both **quantitative** (e.g. randomized controlled trials [RCT]) and **qualitative** (e.g. focus groups, interviews) research approaches from combined graduate and post-graduate experiences as well as prior work experiences (e.g. as research assistant/coordinator).

Since starting my appointment in 2013, I have established a productive research area in **pharmacoepidemiology** focusing on two important problems related to medication use – medication adherence and medications in pregnancy, particularly in **rheumatology/rheumatic diseases**. In 2017, I expanded my scope to a second research area of studying the **epidemiology** of emerging or previously understudied health issues, applying these in **rheumatology/rheumatic diseases** but also expanding to **oncology/cancer**.

Pharmacoepidemiology

Although disease treatment options are now better than they have ever been, it remains a challenge to ensure that patients follow and complete their treatment regimen. Medication non-adherence has been declared by the World Health Organization as an epidemic, costing billions of dollars in wasted health care resources. It is also a complex problem and an important focus of my Tier 2 Canada Research Chair in Medication Adherence, Utilization, and Outcomes. My approach includes conducting population-based studies using administrative databases to quantify the burden of non-adherence, assess impacts on patient outcomes, and more recently. delineate patterns of medication use/adherence, specifically in rheumatic diseases. I also conduct prospective studies to evaluate patient-targeted adherence interventions as well as provider-targeted adherence interventions. I particularly focus on the latter, which is novel in adherence research and consistent with transformative changes in the Canadian healthcare system to address the needs of an aging population and rising costs of healthcare. I am particularly interested in merging two initiatives - first, enabling healthcare providers to practice to the full extent of their training and capabilities and second, applications of electronic health (eHealth) technologies. Unexplored ways to support practice with eHealth may facilitate communication and information exchange (e.g., between provider-patient, between provider-provider), enhance care, mediate adherence, and ultimately improve patient outcomes. As an example, I completed a proof-of-concept study showing the impact of a collaborative care model for gout involving rheumatology, pharmacy, and dietetics supported by shared electronic medical record on adherence, clinical, and humanistic outcomes. Currently, I am completing analysis of a pragmatic, cluster RCT of a community-pharmacist initiated, text message-supported adherence intervention for asthma which involved province-wide recruitment and follow-up of 271 participants with asthma.

Canadian data has shown that between 59% and 64% of women take at least one prescription medication during pregnancy. Much of this exposure occurs because more than half of pregnancies are unplanned but exposure also occurs in planned pregnancies to treat chronic illnesses which impact one in four pregnant women. However, due to the exclusion of pregnant women from clinical drug trials, there is a paucity of evidence on the use of medications during pregnancy. This is problematic for women who must weigh the risks and benefits of therapy. It

is within the context of this unmet need for evidence for women with chronic disease who are pregnant or considering pregnancy and their health care providers that my research area on **medications in pregnancy**, which falls under my Tier 2 Canada Research Chair in Medication Adherence, Utilization, and Outcomes, aims to address the knowledge gap on medication utilization and safety during pregnancy. My approach includes conducting **population-based studies** using **administrative databases** to generate evidence on the perinatal impacts of medications on maternal and neonatal outcomes, specifically with **rheumatic diseases**, which disproportionately impacts more women as compared to men. A notable example, a population-based cohort study led by a PhD student within this program showing that use of biologics during pregnancy is not associated with pre-term deliveries or having infants born small-for-gestational-age was published in the top rheumatology journal, the Annals of the Rheumatic Diseases in March 2018. It has garnered an Altmetric attention score of 453, placing it in the top 5% of all outputs scored by Altmetric. In addition to observational studies using administrative databases, I also conduct **prospective studies** involving both quantitative and qualitative methods to better understand information and support needs of women with rheumatic diseases who are pregnant or planning pregnancy and how they make decisions regarding medications.

Since the start of my appointment, I have obtained **\$691,863.80** in competitive research funding as principal investigator to support my research in the area of pharmacoepidemiology and have **25** published (or accepted) articles.


Epidemiology

The applied nature of epidemiology has allowed me the opportunity to expand into a second research area of studying emerging or previously understudied health issues in 2017. There are two that I have obtained funding for and am currently workin on. First, is changing epidemiology of colorectal cancer (CRC) as although historically considered a disease of older persons with marked oncset of disease after the age of 50, recent research and news headlines have reported an increasing risk of young-onset (y)CRC, that is, CRC diagnosed in individuals who are below 50 years of age. Understanding the epidemiology of yCRC is needed to inform controversies expanding screening strategies as well as informing treatment in light of uncertainty regarding best practices. Works that I have done to date have led to the establishment of my Colorectal Cancer Outcomes Research program. Second is mental health in inflammatory arthritis as beyond the physical impacts of these rheumatic diseases (e.g. pain, disability), there is evidence for a complex underlying relationship with psychiatric complications that is largely driven by inflammation. Applying the same approach as with my pharmacoepidemiology research area, I conduct population-based studies using administrative databases as well as prospective studies involving both quantiative (e.g. online surveys) and qualitative methods (e.g. semistructured interviews). Since expanding my work to add this research area in 2017, I have obtained \$695,891 in funding as principal investigator to support this work and have 1 published (or accepted) article (related to this area).

(9aii) Research Program Knowledge Translation and Dissemination

Because of the clinical and practical implications of my research, knowledge translation and dissemination to users and stakeholders (e.g., patients, clinicians, healthcare policy makers) is important. I collaborate with clinicians (including pharmacists, rheumatologists, oncologists, colorectal surgeons) in all of my research. As well, I have establised partnerships with patient groups nationally and internationally. These include the Arthritis Research Canada Patient Advisory Board and the Canadian Arthritis Patient Alliance for my research in rheumatology/rheumatic diseases and Colorectal Cancer Canada and the Colon Cancer Coalition, Colorectal Cancer Alliance, and COLONTOWN in the United States for my research in cancer/oncology. My research team and I have established several social media channels to support promotion of our research including: 1) a Twitter account that I maintain (@maryadevera, 1,712 followers) and 2) a Twitter account (@CCOR_Study) and Facebook page (https://www.facebook.com/CCORStudy/) for my Colorectal Cancer Outcomes Research program which is maintained by a Research Coordinator. Finally, as listed in Section 9e, published and current research have garnered considerable oneline and/or media attention.




